The lecturers' fees were last adjusted by 20% on 01 June 2010; however, in view of the full implementation of the Salary Standardization Law 3, which increased the salaries of government employees from 2009 to 2010, there is a need for further adjustment of the lecturers' fees to make them comparable with their equivalent full-time faculty. This proposal is in consonance with the BOR approved resolution (1090th Meeting of the Board of Regents held on 28 September 1995), which provided that "henceforth, lecturers' rates shall be adjusted with the adjustment of the salary of the equivalent base faculty ranks".

The proposed rate adjustments will make UP lecturer rates more competitive with those of other universities, thus enabling UP to retain/attract high caliber lecturers to supplement UP's faculty and resources.

## Highlights of the Discussion

- 1. Student Regent Pangalangan inquired why the proposal only covers UP Diliman. Vice President Florendo clarified that the matter was discussed at the last President's Advisory Council (PAC) and the resolution was to propose it systemwide.
- 2. President Pascual amended the proposal on the floor to make the increase in lecturers' fees across the system, effective second semester and second trimester AY 2015-2016.
