DD. Institution of a B.S. Chemical Engineering course

- I. The President recommends approval of the following:
  - A. Institution of an "external advisorship" where a person or expert residing in another country may be invited to act as adviser, with a co-adviser from U.P.

The Dean of a unit after consultation with the Chancellor may extend an invitation, specifying details and conditions, to a non-resident expert to act as external adviser with a co-adviser from the University of the Bhilippines. Upon acceptance of the invitation an appointment shall be made by the Chancellor for a stated field and period of time.

B. Establishment of the position of "research fellow" in the University in recognition of research achievement and to stimulate continuing investigation in unexplored areas for the discovery of new knowledge, for a period of one (1) year renewable for a similar period but not exceeding three (3) years.

For appointment as a research fellow a person must:

- 1. have served the University of the Philippines
  for at least five (5) years of Research,
  Extension and Professional Staff (REPS);
- have demonstrated capacity for research as evidenced by projects completed and works published in learned journals; and
- 3. engage in continuing research in the field of expertise.

The fellow must undertake research during the period of the appointment, submit a full report of the work accomplished at the end of every year of appointment and prepare the final report on the completed project for publication and dissemination. Honorarium shall be at least publication and mether paid from private sources or from private sources or from the University. Provided that a member of the faculty may the University for appointment as research fellow, in which case, the rule on minimum teaching load shall not apply.
