B. Extension of the enrolment privileges for children of deceased UP personnel.

UP System

Present policies on enrolment privileges are interpreted to apply only to qualified children of UP personnel who are on active service in the University. Death of a UP personnel means automatic termination of his service to the University, implying therefore that his dependents no longer are entitled to such privileges.

For humanitarian reasons and to help alleviate the family's loss, UPD would like to recommend that dependents who shall qualify for admission to the University or who are already enjoying enrolment privileges prior to the death of the UP personnel be allowed to continue enjoying the same privileges for the rest of the schoolyear with an extension of another schoolyear; provided, that children enrolled for the first time after said death shall be entitled to this privilege for not more than two schoolyears.

of the University of the Philippines System (underscored portion to be added):

UPSystem

"Members of the faculty, officers, and employees shall have the privilege of enrolling in the University for not more than nine units at the undergraduate level or six units at the graduate level a semester at reduced rates in courses that shall be beneficial to their regular work in the University or their career development, subject to the approval of the Chancellor or his authorized representative. In the case of non-teaching personnel, the courses shall be taken after office hours."

 - C. Proposed amendment of Article 243 of the Revised ... (cont'd)
 - C-1. In this connection, for purposes of automatic promotion of faculty who earn a Ph.D., the following rule shall be applied:

AUTOMATIC PROMOTION. - A FACULTY MEMBER WHO OBTAINS FROM A REPUTABLE INSTITUTION A PH.D. OR ITS EQUIVALENT IN A FIELD PERTAINING TO THE UNIT TO WHICH THE FACULTY MEMBER BELONGS, SHALL BE GIVEN AUTOMATIC PROMOTION, IN ACCORDANCE WITH RULES AND REGULATIONS PROMULGATED BY THE BOARD OF REGENTS: PROVIDED, THAT SUCH PROMOTION SHALL TAKE EFFECT UPON COMPLETION OF THE PH.D. OR ITS EQUIVALENT; PROVIDED; MOREOVER, THAT THE RANK ATTAINED THROUGH MERIT INCREASE/PROMOTIONS EARNED BY A FACULTY MEMBER PURSUING A PH.D. PROGRAM WHILE SIMULTANEOUSLY TEACHING OR PERFORMING OTHER FUNCTIONS IN THE UNIVERSITY SHALL BE TAKEN AS BASIS FOR THE AUTOMATIC PROMOTION.

Note: Portions of existing Board resolutions and administrative issuances by the President or any other University official that are inconsistent with the foregoing proposed rule shall be deemed amended or repealed accordingly as the case may be upon approval of the proposed rule.

D. Payment of a One-Time, One-Step Incentive Pay in 1986 to U.P. personnel out of the 40% of the increase in collection of tuition fees from the 2nd semester of SY 1984-85 to the first semester of SY 1986-87. Any deficiency of this source of funding shall be temporarily paid out of any available amount under the General Fund. (Please see Appendix "B" for the guidelines.)
