The expansion will automatically amend the resolution of the Board of Regents adopted at its 828th meeting on 21 Docember 1972, as follows:

"Sec. 14. There shall be an executive committee of University Council with the Chanceller as chairman and composed of the officers of the administration, and the deans and directors of academic units, and three members at large as members, the last three to be elected by the University Council from among the members thereof for a term of one year without prejudice to reelection for another year. In no case should a member serve for more than two consecutive years, except those who are members by virtue of their positions. The functions of the executive committee shall be those set forth in the Revised University Code."

Justification: It is believed that the three membersat-large who are not holding any administrative position will contribute to a more balanced perspective in the deliberations of the Committee on matters that are brought to its attention.

b. Confirmation of the Memorandum of Agreement between the University of the Philippines at Los Baños and the Los Baños Rural Bank, Inc., pertaining to the UPLB-LERB Payroll Agreement which provides a mechanism whereby all staff and employees of UPLB shall withdraw their salaries through the LBRB.

The Agreement stipulates, among others, the responsibilities of UPLB officials, staff, and employees as well as the role of the LBRB for the offective implementation of the proposed payroll system.

The Agreement shall take effect upon signing by both parties and shall continue to be in full force and effect until terminated by a written notice sent by one party to the other, the termination being effective 60 days after receipt of such notice.
