

1 **V. POLICY MATTERS FOR DECISION OF THE BOARD**

2  
3 Matters recommended by the President for **DECISION**, the  
4 action of the Board being indicated at the end of each item:

5  
6  
7 **A. Proposed Revision of Privileges of Faculty on Study Leave**

8  
9 A memorandum from then Secretary of the University,  
10 Oscar M. Alfonso, dated 5 September 1973 on 'Revised Rules  
11 on Study Privileges of U P Personnel,' states that:

12  
13 Personnel who are on vacation leave with pay  
14 for the entire duration of the term enrolled in or on  
15 study leave for the entire duration of the term shall  
16 be entitled to reduced fees for the maximum  
17 load of nine (9) units (graduate or undergraduate)  
18 during any given term subject to the rules on study  
19 load of the academic program or of the college  
20 enrolled in. [Section C.2 of Alfonso memo,  
21 underscoring supplied.]

22  
23 Because of this provision, in some CUs, faculty on study  
24 leave who enroll in more than nine (9) units are made to pay for  
25 the excess units. It is therefore proposed that the 9-unit cap be  
26 removed, provided that the study load is duly approved by the  
27 graduate advisor and department chair

28  
29 To make this privilege explicit, the following provisions in  
30 the 'Rules for U P Faculty Receiving Full or Partial Load  
31 Reductions for their Study Loads' (1053<sup>rd</sup> BOR meeting, 27  
32 August 1992), under the section 'Privileges of Faculty Fellows  
33 and those on Full Study Leaves,' are proposed for modification  
34 as follows (words in CAPITAL LETTERS to be inserted):

36 **Full Study Leave with Pay**

37  
38 Full deloading from regular faculty duties, full faculty  
39 salary and other benefits for regular faculty in the  
40 active service (including eligibility for promotions),  
41 100% WAIVER OF TUITION, LABORATORY AND  
42 MISCELLANEOUS FEES (EXCEPT STUDENT

8 **FUND FEES) PROVIDED STUDY LOAD IS**  
9 **APPROVED BY THE FACULTY MEMBER'S**  
10 **GRADUATE ADVISOR AND DEPARTMENT**  
11 **CHAIR, rights to some suitable faculty office or**  
12 **desk space (for local fellows, to the extent available)**  
13 **but no further entitlements. Tuition assistance (if**  
14 **studying outside U P ), thesis or dissertation**  
15 **allowance may be granted subject to the**  
16 **recommendation of the CU APFC, the availability of**  
17 **funds and approval by the Chancellor (During the**  
18 **leave with pay, the faculty member of course retains**  
19 **his/her faculty item).**

20  
21 Full Study Leave without Pay

22  
23 Complete deloading from regular faculty duties AND  
24 100% WAIVER OF TUITION, LABORATORY AND  
25 MISCELLANEOUS FEES (EXCEPT STUDENT  
26 FUND FEES) PROVIDED STUDY LOAD IS  
27 APPROVED BY THE FACULTY MEMBER'S  
28 GRADUATE ADVISOR AND DEPARTMENT  
29 CHAIR, subject to normal academic progress but no  
30 other entitlements.

33 **Board action: Approval**
