APPROVAL OF THE PROPOSED REVISIONS IN THE ELIGIBILITY REQUIREMENTS OF THE UP SCIENTIFIC PRODUCTIVITY SYSTEM (SPS)

BACKGROUND:

- The Board of Regents approved the UP Scientific Productivity System (SPS) in its 1199th meeting in August 2005. The SPS aims to: (1) support the development of science and technology and (2) encourage and reward scientific productivity. Deserving scientists shall be conferred the title "UP Scientist" with a monetary award.
- The institution and guidelines of the SPS were patterned after the Scientific Career System (SCS) which was established within the Civil Service pursuant to EO 784 dated March 17, 1982 to support and encourage the development of science and technology.
- The SCS is a closed career system which requires Scientists to devote 75% of their time
 to research and development. For this reason, UP faculty members, despite their scientific
 productivity, are not eligible to apply to the SCS unlike UP researchers (REPS). This
 reality motivated the establishment of the SPS for the UP Faculty members who meet the
 requirements of Scientists in terms of scientific achievements and contributions in their
 respective fields of expertise.
- In February 2013, President Alfredo Pascual reported that UP has finally submitted its first batch of nominated researchers for inclusion in the ranks of non-faculty scientists under the Scientific Career System (SCS). The list consisted of 19 nominees: 3 from UP Diliman, 15 from UP Los Banos, and 1 from UP Visayas.
- By 2013, therefore, UP had two sets of academic staff who meet the achievements
 required of those given the official designation as 'Scientist'—the faculty and REPS. The
 former designation is conferred by the UP while the Council chaired by the Civil Service
 Commission Chairperson with the Secretary of the Department of Science and
 Technology, President of the National Academy of Science and Technology, National
 Research Council of the Philippines and University of the Philippines as members confers
 the designation of Scientist to UP REPS.

The current SPS guidelines, particularly on the eligibility requirements have not been revised since the institution of the SPS in 2005 and even after UP started to participate in the SCS.

RATIONALE:

 The proposed revision is the OVPAA's response to queries such as whether REPS with Scientist status under the SCS or faculty seconded to other agencies are eligible for the SPS. However, their ineligibility is not explicit in the current SPS criteria.

In the case of the REPS, making Career Scientists eligible for the SPS tantamount to "double compensation" or "double awarding" for the same scientific achievements. On the other hand, those on secondment are fully employed in the agency they are seconded to.

2.4.1 Likewise, appointed UP Scientists are not allowed to apply for admission to the DOST Scientific Career System (SCS).

the DOST-SCS, Researchers and REPS who have already been appointed as Career Scientists are no longer eligible to apply to the SPS.

Additional provision. Given the similarities in requirements, applying to both systems would mean "double rewarding" or "double compensation" for the same achievements.
