ART. 244. Any one enjoying student privileges shall be charged an amount equivalent to 25% of the fees for the courses in which he is enrolled rounded to the next higher five pesos (\$75.00). Permission to enroll in more than six units a semester may be granted depending on the individual merits of each case. The full rate of fee shall be applied to the units beyond the first six units.

ART. 244-a. Children and wife or husband of permanent full-time faculty members and of other full-time personnel, including those on daily wage basis, who have served continuously in their work for a period of not less than five (5) years, of the University proper, studying in the University of the Philippines, shall be exempted from the payment of tuition fees, provided said students passed a minimum of twelve (12) units or three-fourths of the total units he was enrolled in on the last day of late registration whichever of the two alternatives is higher, in the last semester attended. (846th B/R, May 30, 1974 superseding 816th B/R, Jan. 27, 1972, and 552nd B/R, Dec. 20, 1951).

Chapter 25 Restrictions

ART. 245. No member of the faculty, officer or employee of the System University/shall publish or discuss publicly the proceedings of the Board of Regents or its decisions, not yet released for publication, without the written permission of the President.

ART. 246. No member of the faculty, officer, or employee of the System University/shall publish or discuss publicly any information concerning a particular college or school, not released for publication, without the written permission of its Dean or Director and the President.

ART. 247. No member of the faculty, officer, or employee shall publish or discuss publicly charges or complaints against any other member of the faculty, officer, or employee concerning his official duties or his private life or conduct. Any such complaint or charge shall be System addressed to the proper authorities of the University/for action before resorting to any other remedy available to the complaining party.

ART. 248. All information concerning a particular college or school shall be given by its Dean or Director; <u>Provided</u>, That the information has to do with his college or school only and not with any System; other college or school of the University/ <u>Provided</u>, <u>further</u>, That the President may prohibit the publication or the **p**lease of any news affecting the University System.

System ART. 249. Authors of articles appearing in University/publications shall be severally responsible for the quinions expressed therein.

ART. 250. No member of the faculty, officer, or employee of the University shall, without permission from the President, practice any profession or manage personally any private enterprise which in any way may be affected by the functions of his office; nor shall he be directly financially interested in any contract with the University System unless permitted by the Board. Violation of this provision shall be punishable by reprimand, suspension, or dismissal from the service.

ART. 251, No dean of a college or director of a school in the System University/shall, unless expressly authorized / the Board of Regents, accept other assignments involving administrative duties and responsi-System bilities in other units of the University/or in any branch of the government service.

ART. 252. Permission to engage in private practice of the profession of faculty members may be granted only if such private practice System may enhance their usefulness to the University/or improve their efficiency. ART. 253. The privilege of private practice, when granted, shall be for a definite period of one year, renewable at the discretion of the President for one-year periods, and under such conditions as may be prescribed by him regarding the nature of the work, the time of performance, and other circumstances.

ART. 254. No member of the faculty on full-time basis may engage in teaching outside of the University of the Philippines unless so authorized under a faculty exchange agreement duly entered into with another educational institution. (793rd B/R, April 7, 1970).*

ART. 255. No member of the faculty shall have dealings with any student involving money, property, or other valuable considerations which might have an influence on the scholastic standing of such student in the University System.

ART. 256. No member of the faculty shall be permitted to give private lessons to any student enrolled in his college or school and to accept payment therefor without the previous approval of the President.

ART. 257. No book, outline, compilation, or syllabus, whether printed or duplicated, shall be used as a basic or required textbook in any class unless approved by a committee in acturdance with the rules prescribed by the President. Prices shall be determined in accordance with the rules issued by the President.

ART. 258. Insofar as it is consistent with their regular duties and if approved by the President, faculty members who are members of the National Research Council and similar institutions of the government may use official time in attending meetings of such institutions.

System

ART. 259. Members of the faculty of the University/shall be permitted to accept invitations to speak at graduation exercises of other schools or colleges, and the time spent in going to and returning from the place shall be counted as official.

ART. 260. No member of the faculty shall enroll as a student in System the University/or in an outside institution without the permission of his Dean or Director and the President. Permission may be granted only when, considering the teaching load of the faculty member, the nature and scope of the course he intends to take, and the time the course requires, such study will not impair his efficiency as a member of the faculty.*

ART. 261. No member of the faculty may i /ite any person who is System not officially connected with the University/to give a lecture or talk on any subject before his class or any group of students without permission from the Dean/Director or the President. Violation of this mile shall subject the faculty member concerned to disciplinary action.

ART. 262. Before a member of the faculty can undertake any research work under the auspices of an organization outside of the University of System, the Philippines, he shall obtain the consent of the proper division or department chairman, Dean or Director, and of the President, and in the System publication of such research, the University of the Philippines/shall be credited, side by side with the outside organization.**
